L.2.7.1 Math Achievement Action Plan – Daphne Brumwell, Superintendent of Education

Daphne Brumwell, Superintendent of Education presented an overview of the Math Achievement Action Plan, as required by the Ministry of Education.

Informed by the Ministry's *Taking Action in Mathematics* framework, the plan must include three sections:

- i) All schools report to provide board-wide improvement efforts and results in mathematics
- ii) Priority schools report to provide intensive improvement efforts
- iii) Priority Schools Provincial key performance indicator report to provide intentional monitoring of student achievement

She listed the schools that have been identified by the Ministry, in either grade 3 or grade 6, as priority schools based on the most recent EQAO math assessment results. She reported that targeted strategies must be implemented in the schools listed.
