H PRESENTATIONS AND REPORTS

H.1 Presentations

H.1.1 School of the Month – Tricia Stefanic Weltz, Director of Education

Director Weltz shared this month's submission from Pope Francis Elementary School in Timmins. A slideshow presentation, including video clips, provided information on a joint school/Porcupine Health Unit initiative called P.A.L.S., *Playground Activity Leaders in School*. This program is a child leadership initiative developed to help reduce bullying through physical activity. Video clips included children being led in various activities by student leaders, as well as, interviews with each student leader on a number of items. The Chair thanked the school for their submission and initiative to participate in such a program.

H.1.2 IGNITE Leadership Program – Jennifer Dunkley, Superintendent of Education

Superintendent Dunkley shared a slideshow presentation on IGNITE, a new internal leadership program developed in partnership with Tamara Nugent. Five NCDSB teachers took part in the initial program.

Superintendent Dunkley shared a program overview, participant feedback and a resolve to continue the program and plan next steps.

Trustees engaged in a question and answer period with the presenter. The Chair thanked the presenter and praised the collaborative efforts of developing this program.
