#### **H PRESENTATIONS AND REPORTS**

#### **H.1** Presentations

H.1.1 <u>Kindergarten & Grade 9 Registration</u> – Daphne Brumwell and Jennifer Dunkley, Superintendents of Education

Superintendents Brumwell and Dunkley jointly presented information on kindergarten and high school registrations. Kindergarten registration involved a marketing plan which included television, newspaper and radio ads/commercials as well as a promotional video made available on the board website. In addition, NCDSB participated in a *Virtual Welcome to Kindergarten* event for parents hosted by Cochrane DSSAB and attended by all four school boards. "I Love my Catholic School" goody bags were also distributed. D. Brumwell reviewed current enrolment numbers and gave an overview of things schools have done, and continue to do, to promote kindergarten registration in their schools.

J. Dunkley presented information regarding this year's secondary school Open House. This included the return to an in-person open house event for students and families, which will happen a little later than usual, at the end of March. She reviewed large enrolment numbers anticipated from OICS and St. Anne's schools, plans to ensure the continued retention of our Catholic students, and the anticipation of welcoming new students to the board.

Superintendents engaged in a question and answer period with trustees.

## H.1.2 <u>Mid-Year Progress</u> – Daphne Brumwell and Jennifer Dunkley, Superintendents of Education

Superintendents Brumwell and Dunkley jointly presented information on mid-year progress which included topics on student achievement, board improvement plans, mental health and wellness, and nurturing our Catholic learning communities; all of which play a part in student success. They discussed struggles in achievement through the pandemic and what schools are doing to increase achievement through various aspects of education. A large amount of data was presented revealing where students are at, what they are doing, and how strategies are helping. This included data on reading, writing and math in elementary level students as well as some secondary statistics. The presenters outlined next steps and shared a video message from the grade ¾ class at Aileen Wright.

#### H.2.8 Business – Keld Scott, Superintendent of Business

#### H.2.8.1 Personnel Update

K. Scott reviewed the Personnel Update, which included four new hires, two increases in FTE, one resignation and two retirements.

Superintendent Brumwell recognized retiring educational assistant Andrea Toner for her never-ending dedication in helping our most vulnerable students over the past 20 years. On behalf of the Board, she wishes her all the best as she begins her retirement at the end of the month.

Superintendent Dunkley recognized retiring vice-principal Sharon Maisonneuve. She commended the numerous leadership roles Sharon has held throughout her career as well as her strong support of Catholic education and the ACCES program. On behalf of the Board, she wishes Sharon all the best on her retirement at the end of the school year.

#### **H.2.8.2** Financial Statements

K. Scott presented the Revised 2020-21 Financial Statements. K. Scott shared that a revision was necessary after receiving an unexpected surplus following the Transportation Department's completion of their financials. As the amount was substantial, a revision was required. The revised statements reflect this change and a motion will be presented.

#### **H.2.9** Director of Education

#### H.2.9.1 COVID 19 Update, Tricia Weltz

Director Weltz presented information including a review on enhanced health and safety protocols that remain in place, an update on Immunization Disclosure Policy, staffing shortages, the return to extra-curricular activities and the gradual return of community use of schools. The Director engaged in a question and answer period with trustees.

#### H.2.9.2 2022-2023 School Year Calendars

Director Weltz presented the 2022-2023 school year calendars for elementary and secondary schools as well as a separate calendar for Bishop Belleau School in Moosonee. She reviewed the process which included meeting and working with co-terminus boards, providing on opportunity for feedback from NCDSB stakeholders and reviewing the feedback. Ultimately, the boards decided on the calendars provided. She reviewed the rationale behind these decisions and reviewed key dates such as start and end dates, breaks and PA days.

#### H.2.9.3 Trustee Determination and Distribution – 2022 Municipal Elections

Director Weltz led the conversation by reviewing the information contained in the Board Package and outlining the responsibilities of the Board to determine the distribution of trustees for the next municipal election by March 31, 2022. Trustees were presented with five possible distribution scenarios ranging from 7-11 trustees. Trustee discussions followed. It was determined that a motion to remain status quo with nine trustees would be presented. It was further agreed that a motion to not declare any municipalities as 'low population' would also be included.

## H.2.9.4 Catholic Ratepayer Verification and Campaign

Director Weltz outlined a proposal of a two-pronged campaign in regards to Trustee Elections 2022. The first being a promotion to ensure Catholic voters vote for the correct Board of Trustees as outlined in the materials included in the Board Package. This would be a pre-election voter verification process and would be promoted through the NCDSB website throughout the months of April, May and June 2022. The second promotion, "Get out the Vote", is proposed to begin in September leading up to the October 24<sup>th</sup> election date and would involve local

trustees in their respective communities. Ideas were discussed and the presentation was well received by trustees.

#### H.2.10 Chair – Board Meetings: Return to In-Person Meetings

Chair Salvador advised trustees that in-person meetings of the Board will resume March 30, 2022. He advised that masks must be worn as social distancing will not be possible.

Trustee Landers wished to remind trustees of the OCSTA convention deadlines and rules of voting by proxy. Chair Salvador reminded anyone who has not already registered for the convention to do so.
