# H. PRESENTATIONS AND REPORTS

# H.1 <u>Presentations</u>

## H.1.1 – Enrolment Update and Impacts on Schools

The Superintendents provided an overall summary of projections versus actual enrolment. Currently, we have welcomed 166 additional students in our schools to our projections in Budget Estimates. Superintendent Brumwell provided a site-by-site synopsis of each elementary school, noting enrolment details, staffing impacts, and program opportunities for students. Based on the structures in place, there are only two schools with classes over 20/under 23 (PFES and AWCO). NCDSB is well within primary cap size limits.

Superintendent Dunkley provided an overview of O'Gorman High School, with details of staffing implications. The ACCESS program is operating under the same schedule as OHS

but also working in the quadmester cycle, to accommodate e-learning via coterminous boards in the province. Superintendent Dunkley reminded the Board of Trustees that this is Year 1 of the Grade 9 De-Streamed Mathematics program. As such, a dedicated Math Coach has been added to the staff.

Trustees engaged in conversation with the presenters commenting on the increase in enrolment being attributed to hard work and quality education; thanked all staff. There was an additional question on building capacities which will be provided to Trustees.

H.1.2 COVID-19: Health, Safety and Operational Guidelines & COVID-19 Protocol for Inter-School Sports, Activities and Clubs — Tricia Stefanic Weltz, Director of Education

Director Weltz provided a general overview of the provisions of the COVID-19 operational guidelines and protocol for inter-school sports. Operational guidelines included topics such as Protective Strategies, Ventilation, Vaccination, and Community Use of Schools. The *Joint Protocol for Inter-School Sports, Activities and Clubs* is a joint protocol of all four Northeast Boards. It includes information on how schools will be able to continue to offer events while maintaining safe protective strategies in our schools.

A trustee commented that they were pleased to see this important progress in continuing these events, such as sports, which are so important to our youth.

#### Personnel Update, Keld Scott, Superintendent of Business

The Board of Trustees reviewed the latest *Personnel Update*, which included two retirements, two resignations, three new teaching and nine new support staff assignments as well as two new Principal assignments. It was also noted that there was an error in the report; Christina MacDougall was assigned to Holy Family School.

## Summer Projects, Keld Scott, Superintendent of Business

K. Scott presented his report along with a detailed update on each Summer Project indicating its completion or current status. He also included good news of Ministry approval for house repairs in Moosonee.

Trustees engaged in conversation with the presenter in regards to the OHS theatre upgrade, ventilation projects, Ministry funding and the availability of Contractors to get the work done on time. Superintendent Scott indicated that the theatre repairs would begin in the spring, increased Ministry funding for the ventilation projects has not been communicated to the Board, and the scope of work and number of projects expected over a two-month period this summer was simply too much given current circumstances (pandemic, availability of supplies/laborers, costs, etc.).

## H.2.9 <u>Director of Education – Tricia Stefanic Weltz</u>

#### H.9.1 DARE Program

Director Weltz provided an overview of the work done on the revisions to the DARE program over the past year, in partnership with the local directors and the local police services. The same approach will be employed with our OPP partners in programs they might offer in communities outside of Timmins.

#### 10.9.2 COVID-19 Immunization Disclosure Protocol

In accordance with the Instructions issued by the Office of the Chief Medical Officer of Health (OCMOH), all publicly-funded schools, child care licensees, private schools, and student transportation providers are required to have a mandatory COVID-19 vaccination policy in place that applies to the individuals defined in the OCMOH Instructions by September 7, 2021, and have the policy fully implemented by September 27, 2021.

T SWeltz reported on several practices the Board has been following and will continue to follow in this regard, including, collection of the vaccination statuses of employees/trustees/third party providers, attestations, proof of vaccinations and the reporting of this data to the Ministry and the general public via the Board's website. Other protocols includes mandatory education for unvaccinated staff as well as bi-weekly COVID testing.

# H.2.11 Chair - COVID-19 Vaccinations, Fred Salvador, Chair

Trustee Landers presented a case for the need of mandatory vaccinations in schools – OCSTA Board has sent a letter aligned with these requirements. The Board asserts that COVID-19 vaccination be mandatory for staff and students. The Board is in agreement that a letter should be sent. Motion to be presented.
